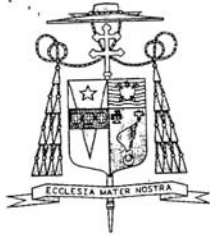

I spoke to Father DePaoli today of my desire that he be reinstated in the active ministry in another diocese for the present time. I gave him the names of the possible dioceses of Metuchen, Scranton and Harrisburg.

Father DePaoli is willing to do anything that I ask him to and therefore is favorably disposed to accepting an assignment in any one of the three dioceses.

I asked him if he had any other diocese that he wanted us to contact. He told me that he did not have any suggestions and was satisfied with any one of these three dioceses.

May I kindly ask you to be in touch with the Bishops of these three dioceses to see if they would be willing to accept Father DePaoli for a reasonable amount of time.

Today Father DePaoli came in to see me at my request. The purpose of the interview was to discuss with him return to the active ministry. He is presently living with his parents.

In view of the publicity that ensued upon the incident involving Father DePaoli, I told Father DePaoli that for the present time it might be more advisable for him to return to the active ministry in another diocese. I told him that by going to another diocese we could put a sufficient period between the publicity and reinstatement in the active ministry of the Archdiocese of Philadelphia. I told him that three dioceses that we were considering to contact were Harrisburg, Scranton and Metuchen.

Father DePaoli spoke very frankly that he felt sad but was most willing to accept this approach. During the many months of his inactivity, working in another diocese always was part of the options that he reflected on. Father DePaoli impressed me with his deep spirituality. He told me that since the very painful episode in his life, he has learned to be more sensitive to the pains and weaknesses of others, especially of his brother priests. He feels that he has grown in appreciation of his priesthood and of the need for prayer and the spiritual life. He has reached the point where he surrenders himself completely to the Providence of God. For this reason, while he feels a certain disappointment in not being able to return to the Archdiocese at the present time, he feels joy in that he is doing what he considers is the Will of God transmitted through his superior.

I told him that after we contacted the three dioceses, we would be in touch with him. I also told him that the process of contacting these dioceses would begin immediately though I could not project how much time it would take before a final decision was made.

In our last Personnel Meeting, following much discussion, you decided that you would speak to Father DePaoli who will be seeing you on Wednesday, May 4, 1988 at 4:00 p.m.

You noted that after you have spoken to Father DePaoli, informing him of your decision that another Diocese would be more appropriate for his priestly ministry, Bishop Lohmuller will then contact the Bishops of Metuchen, Scranton, and Harrisburg relative to their disposition of possibly accepting Father on an experimental basis.

**BACKGROUND**

In early Summer 1985, I was summoned to the U.S. Attorney's office in Philadelphia to accompany federal marshalls to one of our rectories in order for them to conduct a search of the room of the Reverend Edward M. DePaoli. A federal search warrant has been issued for this purpose. Before federal marshalls and myself and the pastor of the parish, we discovered extensive pornographic material in this priest's quarters. Some of these materials had been purchased by him and delivered through the U.S. mail. Several months later he was indicted on one count of knowingly receiving in the mails visual depiction of minors engaged in sexually explicit conduct. After a three day trial here in Philadelphia he was convicted of knowingly receiving these materials and placed on probation for one year.

During this time the Chancery office suspended Father DePaoli's faculties and he resided at Villa Saint John Vianney Hospital, Downingtown and was evaluated at Saint Luke Institute, Suitland, Maryland. The experts at Saint Lukes's recommended that Father DePaoli undergo extensive therapy at the House of Affirmation in Hopedale, Mass.

Father began this therapy in Massachusetts in May, 1987 and concluded the sessions in January, 1988. Following the recommendations of the House of Affirmation, Father was then sent to the Golden Valley Health Center, Minnesota for a 5 week intensified inpatient therapy in a sexual dependency unit (Report 2-26-88 enclosed). Father DePaoli returned to the Archdiocese and is residing with his parents in Royersford, Pa.

I directed him to undertake a two week retreat, which he has done. His Eminence restored his faculties several months ago following the recommendation of the House of Affirmation.

Today I interviewed Monsignor Walls concerning his future ministry. Monsignor Walls had written to me and indicated that he had received clearance from St. Luke's Institute and also had received from them a report indicating that he could return to his previous position as Vicar for the Office of Catholic Education.

Today I told Monsignor Walls that returning him to the Office of Vicar for Catholic Education would not be possible. I explained various reasons why this would not be prudent.

Among the more immediate reasons was the fear that the parents of recent victims were not likely to take any action of a legal nature as long as the Archdiocese has acted strongly. Since he would not be away on an inpatient basis and if he is restored to his previous position as Vicar, it would appear that the Archdiocese had not considered this a serious matter and had taken no reasonable action. This perception of inaction could very well trigger the parents to resort to some kind of further procedure through court action. I told him that I had to be concerned for the victims, for the Church and for him. The victims seem to be at present adequately cared for. He himself was in proper therapeutic care. The concern for possible scandal and the welfare of the Church remains. It is to avoid any further action or publicity which would be harmful to the Church that it was not possible to return him to his original office.

Monsignor Walls understood this though he obviously was disappointed.

I suggested to him that it would be more prudent if he would submit a letter of resignation requesting a leave of absence for health reasons. During this leave of absence he should pursue his intensive therapy and also reflect on what type of ministry he would be willing to consider. I strongly suggested to him that I did not think it would be possible for him to go back into any kind of parochial ministry. He himself said that he had been reflecting on this and thought as a possibility some kind of ministry to assist other priests suffering from alcoholism or other weaknesses. He felt that he could identify with them and therefore could possibly be of assistance to them.

I also suggested to him that he should reflect on other types of ministries such as chaplaincies in hospitals, etc. He seemed to be disposed to any such type of priestly activity.

I told him he could remain at St. John Neumann and continue to assist Monsignor Meehan while he is on his leave of absence. After a reasonable amount of time, he should get in touch with the Chancery to indicate that he is ready to return to active ministry and also provide any fruits of reflection on the type of ministry he would like to carry out. We discussed the period of time and I told him that I had no definite limits to him. I did tell him that the amount of time should be worked out between himself and his therapist. I did also indicate that it would probably last several months and even go for six months.

I told him that he should send his letter of resignation in at his earliest convenience. He said that he would.

Monsignor Walls seemed to be very repentant of his improprieties. He seemed to be well-disposed to doing anything he is asked to do.

MEMORANDUM IN RE: REVEREND FRANCIS P. ROGERS, ordained May 30, 1946.

Father Rogers has been assistant rector at Saint Francis of Assisi Church, Norristown, since May 22, 1959. The pastor of Saint Francis of Assisi Church is the Reverend Charles J. McGovern (ordained May 25, 1929), who was incarcerated briefly in Atlantic City during the past winter. The second assistant at Saint Francis is the Reverend Charles V. Devlin, ordained May 19, 1955.

Some information about the bizarre conduct on the part of Father Rogers reached the Chancery during Holy Week.

Last week Doctor Hoffman, psychiatrist, came to the Chancery to report that Father McGovern, whom he had been treating, consulted with him concerning the complaints he was receiving about Father Rogers's familiarity with boys from the eighth grade and first year high school.

After listening to the doctor's story and after two sessions with Father Devlin, the first of which was in the presence of Monsignor McNally, I sent for Father Rogers. He has taken boys out of school for trips to the seashore, occasionally overnight ones; frequently takes boys in his automobile and to drive-ins. He provides opportunities for them to smoke in his car or the parish garage; has allowed them to drink; taken obscene pictures of them, and showed them indecent magazines.

Complaints made are from some of the boys' mothers, one who quotes her son, "I never want to go with Father Rogers again"; wrestling with the boys in public, lifting them above his head--this he also has done with adult women; an offhand way of speech that is sometimes vulgar and startling.

Father is not in any way contumacious. He very abjectly revealed the history of his weakness: victimized by a boarder in his own home from the time of his earliest recollection until this man died when he was in the sixth grade; habit of masturbation; weak character, inferiority complex; victimized during seminary career by older student who has since left the priesthood.

Familiar with boys in at least two other assignments: St. Rose of Lima, Eddystone (1953-1959); St. Patrick, Pottsville (first assignment, 1946-1949).

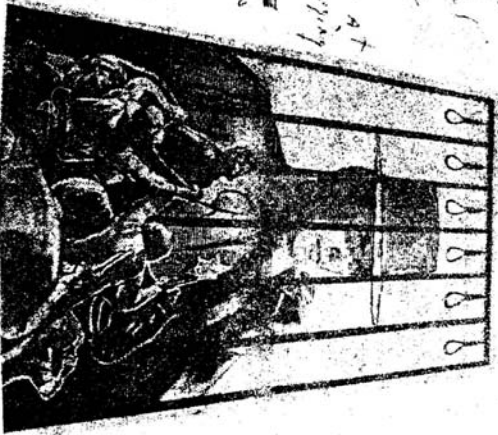

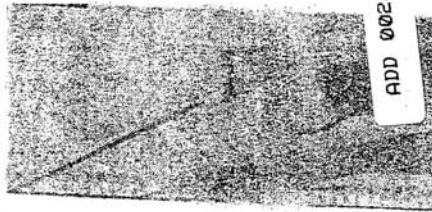

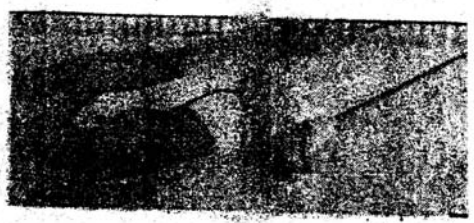

MEMORANDUM

Re: Reverend John H. Mulholland

A group of adult advisers of the CYO called me last evening asking if they could come to the Chancery. They came this morning. They stated that in all there are about 15 adult advisers; 8 of them were here today. They stated they had come in order to put things in proper perspective because they feel that the picture at Saint Anastasia's has been put out of perspective by the group that had previously come to the Chancery.

They had gone to Father Kane concerning this problem and Father told them to come to the Chancery. It was the feeling of the group that a small handful of people were vindictive and tried to level charges against Father Mulholland; they feel he is upright in every respect.

1.                   stated that he has a son 16 years old who took a summer trip with Father for 21 days. He said Father did an exceptional job of showing the boys a good time. He did not ask for any money from the parents or the kids. He claims Father's character is above board. There was Mass every morning and much was taught about the Catholic religion. He claimed there was defamation of character concerning Father and sex.
2.                   has been chief adult adviser for the past 2½ years. He stated that he would never have given any thought to Father's actions; that he noticed nothing out of order and the accusations came as a surprise. He states that he has been working close to Father for two years.
3. A                   has a son           who two years ago took a trip to the west with Father. When he came back he spoke highly of Father, who was instrumental in getting him into the priory. Father does spend a lot of time at the           home.
4.                   has three girls in CYO. All of them are very active. He states that these three have been crushed by the news. He states that Father Mulholland gives his whole time to the parish and to the youth.
5.                   states that his wife took over as chief adviser. His son is the president.
6. Next a girl spoke whose name I did not get. She outlined the many activities of the CYO. It included community action, recreation programs, religious discussions, and other activities during the year. There is a paper drive each month to defray the expenses of the CYO. At this Father spent much of his time.

The group stated that there are about 73 members of the CYO; about 50 are active. They used some names of people whom they thought were here. They claimed that           is easily swayed and is used as a pawn, and that there is an adult behind this.

Background on the Reverend John H. Mulholland

Dear Doctor:

The following is the background on the testimony which is enclosed in the folder. Father Mulholland has had three appointments--June 1965 to June 1966 at Saint Patrick Church, Kennett Square; June 1966 to June 1968 at Saint Joseph Church, Hatboro; and June 1968 until the present at Saint Anastasia, Newtown Square.

The first series of problems was terminated in September 1968 when Father Mulholland was called to the Chancery to speak with Bishop McDevitt. The memorandum of that interview is enclosed. It concerned certain boys from the Hatboro parish and the discovery of certain letters by . . . . . Although the date of the interview was September 1968, and by this time Father Mulholland was serving in Saint Anastasia, Newtown Square, he was still returning to the Hatboro parish for meetings with these boys. Part of the interview with Bishop McDevitt was a promise that he would stop going back to the parish. We had some reports later on that he was still returning to Hatboro. In Hatboro, besides the activity with boys, there is also the phenomenon of his attempting to split the parish into factions.

The second group of problems takes place in Saint Anastasia parish, Newtown Square. It centers around a totally new group of boys; in fact, a different group of boys in the second year than in the first year in the parish.

Enclosed is the testimony of Father Joseph Kane, pastor of Saint Anastasia parish, who was called in concerning the credibility of the people whom we had interviewed. Father Kane stated that . . . . . his mother, and his sister were very credible people. He also stated the same for the other boys involved in the CYO who would offer testimony.

Concerning my interview with Father Mulholland

On Monday, October 26, after having finished all of the interviews, I called Father Mulholland and asked him to come to the office. He came at two o'clock that afternoon. Over the telephone he himself mentioned that I probably wanted to see him about the CYO. When he came to the office I let him speak for the first ten minutes. He was explaining the problem that he thought I was going to bring up--namely, the different personality clashes that had taken place in the CYO and the arguments which ensued. After about ten minutes I explained to Father Mulholland that that was not the chief problem I wanted to discuss with him. I mentioned his previous interview in the office with Bishop McDevitt and the promises he had made. He claimed he had kept all of the promises and had had no problems since then. He felt he had matured much since that time.

I then questioned him about wrestling with boys and he eventually did admit that there were some occasions when he did that. I then told him that we had the testimony which amounted to bizarre behavior. I mentioned to him that this behavior caused us to have real doubts concerning the problem of homosexuality. He asked what the behavior was. I mentioned the trips that he took with boys, the change in the relationship when they returned from these trips, the wrestling matches at CYO meetings, running his hand up and down the leg of one of his favorite boys, the incident of having one of these boys with his head in Father's lap with Father stroking his hair, the intimate names that he uses for his friends, having boys in his room, picking up and taking home the president of the CYO who was one of the boys on the trip, and the saying of Mass in the basement at a strange hour when only his few friends are present. At no time did Father deny any of the things which were brought up to him. He merely stayed silent and accepted them as true.

I then told him, as an accomplished fact, that we wanted him to go to you for an evaluation with the distinct possibility that after talking to him you would want him to go to Downingtown. It was only after awhile that it got through to Father what I was trying to say. He then turned to me and said, "I guess you mean you want me to be a patient for a period of time." I explained that that was exactly what we wanted.

All of this consumed only about twenty minutes since I knew that Father would never admit anything on his own but sort of had to be confronted with the facts. After this twenty minutes, when it came home to him what was going to be expected of him, he sat back and asked if I had a few minutes. I told him I did. He then began to talk about his feelings. He stated that he felt bitter at the whole human race and had difficulty accepting different people in authority, although he felt differently toward this office especially after the very nice interview he had with Bishop McDevitt. He said that he felt often that no one thought of him. I told him that our whole concern was his happiness and the fact that he would work through this problem. It is for this reason that we are asking him to accept professional help. I told him that we did not expect him to be totally open with us, who were his superiors, but hoped that he would be able to open up to someone whose only task was to help him with his problem. I told him that all that we could see was very strange behavior which brought about a certain amount of scandal in the parish which caused us to have to move on him. Just what the problems are, how deeply they are rooted, or in what way they will be cured or at least treated, is beyond our competence. This is why we are helping him to seek professional help.

At the end of the interview I explained to him that all of the records which we have concerning his behavior would have to be forwarded to you before he would see you so that you would understand some of the background, Father Mulholland, "surely the doctor cannot be working in the dark, he has to know what happened."

I also made it clear to Father that there was no possibility of his remaining in the parish. I mentioned to him that in a couple of weeks there would be a series of changes and that this difficulty would be taken care of at that time. Just what we do with him in a couple of weeks would be very much determined by your evaluation of him and the degree of his co-operation.

I tried to make it clear to him that the purpose of this evaluation was to see if he would have to go to Downingtown or not. I explained that we would have to be guided by your evaluation.

Father Mulholland came to the Chancery today to discuss his case. He explained some of the ramifications which had not been brought to light. However, these were very minor. In light of the group of people that came to the Chancery on November 3, I told him that we would have no difficulty allowing him to stay at St. Anastasia, since the amount of scandal given seemed to lie only with a very small minority. I further told him that, as far as we were concerned, it was merely a matter between himself and Dr. Zanni as to what the future will hold. Father seemed very grateful for the support and stated that he might want to leave the parish in May, anyway, but that it meant a whole lot to him not to be changed at an odd time in the year.

I then called Dr. Zanni to state what had happened and to fill him in on the information received by the group which came to the Chancery. Dr. Zanni, with this new information, decided that he would probably not ask Father Mulholland to go to Downingtown. Father Mulholland's final appointment with Dr. Zanni is Thursday, November 12.

The Office for Communications has been trying to identify a "writer" for their office with little success. You will recall that last year they hired Larry Doherty; however, he lasted only 6 weeks. They have one possible candidate; however, he is a laicized priest. Although in good standing with the Church and with a favorable letter from Monsignor Flood, his Pastor, Monsignor Palmieri (who is on the search committee) and I prefer not to go this route.

On several occasions, the Office for Communications has inquired about the availability of Father Delli Carpini for this position. Presently, Father Delli Carpini works under the supervision of Monsignor Palmieri. However, he has been doing a great deal of writing for Cathy Rossi, e.g. your Millennium Minutes and miscellaneous articles, in addition to the many homilies and talks he prepares for your use. He only comes into the office building on Mondays and Tuesdays.

Monsignors Lynn and Palmieri believe that even though Father Delli Carpini does a great deal of work, he could be doing much more. He continues to do well at the Cabrini Home as chaplain. Monsignor Lynn is concerned that it will not be healthy for him and could create problems if he has too much time on his hands.

We would like to assign Father Delli Carpini to work in the Office for Communications as a writer. There is office space available for him there and the Office for Communications would assume his salary. We envision that he would continue to be under the supervision of Monsignor Palmieri for purposes of his "personal" issues and continue to assist him on a few Chancery projects. However, he would be accountable the remainder of the time to writing projects for you and for the Office for Communications. For public information, Father Delli Carpini would still be assisting Monsignor Palmieri. There would be no need to publicize the assignment as "writer." (Regarding your previous concern about his mentioning that he writes for you, we were able to address this matter with Father Delli Carpini discreetly, without any reference to your having raised the issue.)

Father Shea [TFS] was interviewed at the Office for Clergy by Reverend William J. Lynn [WJL] and Reverend Michael T. McCulken. The reason for the interview was to review with Father Shea allegations that had been received through the Archdiocesan attorney, Mr. John O'Dea.

WJL clarified with TFS that he was assigned to Saint Helena from 1969-75.

WJL stated that the claims included genital abuse at the Rectory and Cape May. He asked TFS if he had a home in Cape May. TFS stated that parents were in Stone Harbor and he was staying in a motel at Cape May. TFS picked up and a friend and they spent the weekend with him. After which time he drove them back home. WJL stated that another man was also making allegations and was going to put everything into writing to Mr. O'Dea. As soon as the letter is given to WJL, he will apprise TFS about what is alleged.

WJL then asked TFS if he knows and if it is true. TFS replied that he did know the man as a youngster and that "maybe it might be true, I don't know. What does it mean?" WJL asked again if anything did happen, saying that he had to know. TFS stated yes, it did happen. WJL asked how many times and if there was genital contact. TFS stated yes sometimes there was genital contact and that he did not know how many times. TFS admitted that

it did occur in the motel and in the rectory.

WJL asked if he was involved with others and TFS stated that he was similarly involved with a                      but does not know if that is the other person                      is referring to. TFS stated that he does not remember any other kids. WJL asked if there was genital activity and TFS said that there was touching and that it happened twenty years ago.

TFS was rather emotional and his color changed quite a bit. WJL asked if he was alright and TFS said that he was. WJL asked TFS to leave the parish. TFS said that he takes care of his mother, who lives in Saint Barnabas. He asked if he should resign and that he was ready to resign. WJL told him that we are here to help and that we know it is overwhelming. TFS asked if                      was suing the Diocese and WJL said he did not yet know.

WJL explained that the policy is to have the priest immediately leave the parish setting if he has admitted guilt and go to Immaculate Conception parish until Cardinal Bevilacqua can review the situation. Usually there is treatment required. TFS asked what is he to do with his mother, since his sister works and he said that this will kill her. Then he asked if he needs to leave tonight and WJL explained that he should to protect himself and the parish. He will go to Immaculate Conception for a residence and that he can continue to take care of his mother.

TFS was very emotional. He asked about resigning or taking a leave of absence. WJL explained that normally treatment is requested and is he willing to do so? TFS asked if this will hit the papers. To which WJL replied that he hoped not but that there is cause for concern since this law firm is known for that.

TFS asked if he should tell Father John Cox, his pastor? He has been there six years with no problems. WJL asked TFS if anything else happened besides during his stay at Saint Helena. TFS replied that his father had lost a leg and that                      was about fifth or sixth grade and an altar boy. WJL asked how much TFS trusted Father Cox concerning the possibility of sharing the allegations with him. At first TFS seemed hesitant to share anything with Father Cox but later stated that he would share that allegations had been brought but did not involve Saint Clement parish.

TFS asked about staying at his mother's home tonight. WJL said that he could while arrangements are made at Immaculate Conception with the pastor. TFS wondered aloud why now, after twenty years. WJL indicated that sometimes it is for money but

that the Archdiocese does not settle with claimants; although, the Archdiocese does pay for therapy for claimants if the priest has been guilty. He stated that usually claimants come into the office, but this one went to the lawyer. He indicated that Mr. O'Dea did not think, this was going to be a lawsuit.

TFS asked how long does treatment at Downingtown take. WJL explained anywhere from three months to one year. TFS inquired of the treatment offered. WJL explained that it involved group and individual therapy, going over the situations of life in order to help resolve issues, to see if risks are still present. The need for treatment right away rather than a leave of absence is to show responsibility by Father Shea and by the Church in this situation.

TFS continued by saying what will he tell his mother concerning Downingtown. WJL said that if he told her now that he was taking time off for personal problems such as depression then it would not be unreasonable to his mother to hear that he was going to Downingtown. WJL again stated that we were here to help and to affirm to TFS that he is supported. TFS said that he understood that. WJL told TFS not to do anything foolish, to which TFS replied that he doesn't have the guts to do something like that. TFS asked if he could take some things out of the rectory later in the evening and talk with Father Cox. WJL agreed and told him that Father Cox could call WJL if he had concerns.

TFS asked regarding the statue of limitations which is past and then about a civil suit which is still a possibility. TFS said that he has no money that they could get out of a civil suit. WJL told TFS that the Archdiocese does not make cash settlements but does pay for therapy, especially when the priest has admitted guilt as TFS has. He continued by saying that sometimes the claimant only wants an opportunity to meet with the priest and talk; although others do sue.

TFS asked when will he would know a course of action and WJL said that he would inform Cardinal Bevilacqua today. TFS was concerned about saying Mass, finances, directions to Front and Allen, how he was to get to Downingtown, and representation by an attorney if needed. WJL offered explanations to his questions and affirmed for TFS again that we are here to help and support him through this. In regards to other persons to help take care of his mother, TFS did say there were a few nephews besides his sister.

TFS wondered who within the Office for Clergy sees this information. He was told that within the Office for Clergy only the priests see it. He asked if he had a good record otherwise and was told yes. He stated that when he was changed from Saint Helena

this situation stopped and that was it. He did not seek any help, he did not need it. He stated that was fooling around with other kids his own age and that TFS did not start him into anything like this. WJL said that it is possible TFS was seduced into it.

TFS said that he is not very outgoing, not a great conversationalist, and that he never had money to travel like many of his contemporaries in the priesthood. The kids were fun to be with, they looked up to you. TFS said that he kept a lot of things to himself, and has been taking care of his mother. When his father was dying he told TFS to take care of his mother and for ten years he has been doing that on his days off. He said that his sister has her problems, that she does visit, but the burden is on him. He said that at Saint Clement he was the priest who did most of the work and filled in for Father Cox. When at Saint Helena he was also always busy, taking on whatever needed to be done, not really knowing how to say no.

WJL said that maybe these are some of the issues to be addressed in treatment. WJL said that we would call TFS tomorrow with further direction.

Attached is a copy of my December 4, 1992 memorandum to you summarizing allegations of sexual abuse brought against Father John Cannon by [redacted]. Father Cannon denied the allegations but was cooperative with a psychological evaluation. Attached also is a copy of my February 8, 1993 memorandum summarizing the results of the evaluation. Father Cannon was 70 years old at the time. You did approve inpatient hospitalization at the time. The inpatient hospitalization never took place and I am at a loss as to why this never happened. No further complaints have been brought against Father Cannon. At the time [redacted] wanted a cash settlement which we refused.

Excerpts from these memos may be blocked out for attorney client privilege. I only have copies in our file. The Grand Jury has the original file.

On July 23, 2002, Bishop Dattilo called me to inform me that [redacted] who lives in Lancaster, had approached the Harrisburg Diocese. He went to Harrisburg because Saint Monica's Camp, the place where the alleged abuse took place, is in the Harrisburg Diocese. He told Bishop Dattilo that I had told him at the time that his allegations were not credible. Bishop Dattilo said that states he has a lawyer and all he wants is to be believed. I filled Bishop Dattilo in on previous demands.

[redacted] told Bishop Dattilo that Father John McCole could verify what he alleges. [redacted] had provided a different priest name before, who did not back up his allegations. I spoke to Father McCole. Father McCole took Father Cannon's place at the camp. Father McCole stated there were vague stories about Father Cannon but nothing specific. He stated that no one ever came to him and made specific allegations, but that there was talk that "Father Cannon was strange."

I told Bishop Dattilo I would review the file and make recommendations regarding the situation.

I met with Father Cannon on August 2, 2002 to inform him that these allegations have resurfaced. Father Cannon denied the allegations again. He stated that there was a problem at the camp with a group of Benedictines trying to start an agricultural school nearby. He said one of them had problems and came to say Mass for a time until he was let go. Father Cannon feels he may have been confused with this priest.

Father Cannon is 80 years of age and is assigned as Chaplain at Saint Joseph Home for Aged. He is willing to retire but would prefer to stay where he is. Even if he retires, I do not know if there is enough evidence to keep him from exercising his priestly ministry. He taught high school for 35 years and there are no allegations other than

I have consulted with legal counsel and there is no legal liability in this situation.

Since Father Cannon is open to retirement if suggested, I think it best to go that route. He is the oldest priest in active ministry at this time. However, I do not believe there is enough evidence to restrict his priestly service in retirement at this time. This might be a case that could be presented to the Review Board when it is established.

Recommendation:

That Father Cannon be asked to request retirement.
